Biosecurity

What is biosecurity?

Biosecurity is the protection of the economy, the environment, social amenity or human health from negative impacts associated with the entry, establishment or spread of animal or plant pests and disease, or invasive plant and animal species.

Why is biosecurity important?

Biosecurity is fundamental to the health, well-being and prosperity of all Victorians. Victoria has a strong record of identifying and managing biosecurity risks for the agricultural production sector but it is time to look to the future. Our natural environment and primary industries face new and emerging biosecurity threats which bring new challenges and require new solutions.


